City of Chehalis Ordinance No. 509-B requires that all businesses that conduct business activity within the city limits of Chehalis obtain an annual business license. The annual licensing period for each license commences on the date of issue of each year, and normally expires one year later. Temporary business licenses do not require renewal.

The business license document (the top portion of this page) must be conspicuously displayed in a public area of your business location. Businesses that do not have a location within the city limits of Chehalis, but are conducting business within the city, must have a copy of this license available for inspection by city employees or any citizen being contacted.

The initial license fee is \$35 and must be attached to the business license application form. That fee is non-refundable. The annual renewal fee is \$15 and must be received by the city prior to its expiration date each year. Temporary business licenses do not require renewal. Licenses issued to non-profit organizations must be renewed annually, but the renewal fee is not required.

The city will attempt to mail out renewal notices at least 30 days prior to the expiration date of each license. If you do not receive a renewal notice, please contact the Chehalis Community Development Department at (360) 345-2229 for renewal information, and to make sure we have your correct business information.

Any change to your business operation, product line, ownership or location must be reported to the city. There is no charge for updating your business information. Submit a standard business license application form and check the 'update' box. If you are changing business locations, a premises inspection will be required. The city will contact you for that inspection at your convenience. Call (360) 345-2229 for questions on building and fire codes relating to your business.
